Established in 2022, the Mongolian Early Childhood Development Network (MECDN) is co-led by the Lorinet Foundation and UNICEF Mongolia, with endorsement from the Ministry of Education of Mongolia (formerly the Ministry of Education and Science). The network serves as a platform for connectivity, awareness-building, policy engagement, and evidence-based knowledge advancement, ultimately strengthening Mongolia's early childhood ecosystem.

Through this report, Lorinet Foundation shares the MECDN's progress and achievements during its formation period, while outlining future priorities. The outcomes and insights gained validate the need for coordinated, multi-sectoral efforts and highlight the importance of collective action in advancing the well-being of Mongolia's youngest children.



CONTENT

1. EXECUTIVE SUMMARY

Promoting Early Childhood Development (ECD) in any country requires an engagement of multiple sectors and stakeholders, making networks an ideal platform for driving coordinated actions. Networks provide critical infrastructure to connect diverse actors, fostering cross-learning, alignment, and collaboration.

The fragmented nature of Mongolia's early childhood development ecosystem resulted in the disconnect that limited the exchange of practices, led to duplication of efforts, and hindered collaboration. To address these challenges, Lorinet Foundation and UNICEF Mongolia, with endorsement from the Ministry of Education (MOE), jointly established the MECDN in 2022.

GOAL

To connect local stakeholders dedicated to advancing early childhood development and strengthen the coordination and collaboration among them.

KEY FUNCTIONS

- **Connectivity & Learning**: Enable knowledge and practice exchange, foster collaboration among the members, and build their capacity.
- Awareness Building: Raise public awareness about the importance of integrated early childhood development, particularly among parents and caregivers.
- **Policy Engagement**: Encourage and support members' active participation in the development and implementation of relevant policies.
- **Evidence-based Knowledge Advancement**: Develop and disseminate evidencebased knowledge to support informed decision-making by ecosystem stakeholders.

Since its inception, MECDN has rapidly evolved into a dynamic platform, convening over 30 institutional players across early childhood protection, education, nutrition, and health. These members represent academia, development partners, international and local non-governmental organisations as well as private and public sectors, underscoring MECDN's role as a unifying platform.

During the formation phase (2022-2024), various initiatives were piloted to deliver network's core functions, strengthen governance and identify pathways for further advancement.

At the member level, MECDN has played a pivotal role as a connector, facilitating the exchange of critical information and fostering more coordinated efforts. Members consistently recognise the platform's ability to bridge gaps, share best practices, and drive collaboration.

At the wider ecosystem level, MECDN has been instrumental in engaging key government bodies and contributed towards shaping the major thematic policies. Its increasing importance was underscored by its close engagement with the interministerial National ECD Council.

The establishment of the Steering Committee and Secretariat in November 2024 marks a key milestone in the network's growth, laying the foundation for the next stabilising phase (2025-2026). This phase will focus on strengthening co-ownership among members and guide the transition to a more structured governance model.

4. IMPACT & OUTCOMES

4.1. MEMBER IMPACT

The active engagement and sustained interest of key ecosystem players in MECDN underscore its vital role in strengthening Mongolia's ECD ecosystem. By fostering collaboration and creating a shared platform for multi-sectoral stakeholders, MECDN has become a valuable connector facilitating knowledge and practice exchange. Insights from the member surveys confirm MECDN's ability to bridge gaps and foster synergies.

Collaborative Learning and Tangible Impact:

We joined MECDN to learn from others. One tangible result was the integration of fellow member OneSky's play-kit tool into our grant proposal, which secured a \$20,000 grant. – Munguntsetseg, Programme Resource and Quality Director, WV Mongolia

Enhancing Intervention Quality:

MECDN allows us to promote our work to the wider ecosystem while also providing learning opportunities to improve the accessibility and quality of our interventions. - Good Neighbors Mongolia

Access to evidence & Bridging Grassroots X Government:

MECDN allows us to access evidence-based knowledge. Moreover, it offers unique never seen before bridging support for the smaller grassroots organisations to engage with government players, allowing us to share feedback and address barriers more effectively. - Munkhtuya, Kindergarten Principal, CNCF

Comprehensive Resource Platform:

It is a one-stop resource platform that provides a holistic understanding of different aspects and solutions of the integrated ECD. Field visits provide unique opportunities for the private sector players like us. Practical Learning Through Field Visits:

Field visits are extremely useful and practical learning tools. After members visited our Family Centre, UNICEF Mongolia not only invited us to explore a partnership on their community engagement pilot but also used our centre model for the establishment of similar ECD centre. – Gereltuya, Programme Director, OneSky

4.2. WIDER IMPACT

4.2.1. POLICY AND GOVERNMENT ENGAGEMENT

The Ministry of Education (MOE) played a pivotal role as an endorser in the successful launch of the MECDN, generating immediate interest from major stakeholders. Following the launch, the MOE demonstrated continued leadership by inviting MECDN to contribute to the revision of the National Policy on Promotion of Integrated Early Childhood Development. This engagement provided an opportunity for the members to share feedback and recommendations, resulting in a stronger policy document adopted by the government in 2023.

To further promote MECDN, MOE included its official launch ceremony in the agenda of the 2023 National ECD Forum. Co-organised by multiple government agencies, the event brought together early childhood sector public officials and service providers from all 21 provinces, highlighting MECDN's growing prominence.

Recognising the integrated nature of ECD, MOE also facilitated the engagement of other key government stakeholders such as the Ministry of Family, Labour and Social Protection (MFLSP). As a result, MFLSP officials became actively involved in network's activities and invited selected members to contribute to the revision of the Childcare Service Law.

MECDN's rising profile led to further recognition when it was invited by the newly established inter-ministerial National Council on Integrated ECD, which is represented by the Education, Health, and Social Protection ministries. This engagement laid the foundation for ongoing engagement and exploration of synergies with the council's priorities.

4.2.2. PUBLIC AWARENESS

Members have consistently emphasised the critical need to raise public awareness about the importance of ECD, particularly among parents and caregivers. This focus is seen as essential for driving societal and cultural changes, further validating the coleads' original proposition to choosing public awareness as one of MECDN's core functions.

To address this need, a dedicated social media page featuring high-quality local language thematic content was launched in collaboration with member organisation, Mongol Content LLC. Leveraging their outreach and influence, Lorinet Foundation, UNICEF Mongolia, and the MOE actively promoted this digital resource among parent and teacher groups, public servants across all 21 provinces, and at various thematic events.

4.3. STRENGTHENED GOVERNANCE

Co-leads, Lorinet Foundation and UNICEF Mongolia, in addition to leading the delivery of the MECDN's core functions, have also dedicated efforts to strengthen the network's governance.

Governance Strengthening: Series of smaller group meetings with experienced members were organised to refine the Terms of Reference (ToR) and explore pathways for deeper collaboration and sustainability. These efforts culminated in reaching a significant milestone – the establishment of the Steering Committee

5. NEXT STEP

Building on its successful formation, MECDN is moving into the next phase, focusing on further strengthening and stabilisation of the network. This phase will serve as a base for the MECDN to further progress through next stages of network development: from connectivity to alignment, and ultimately to collaboration, with latter requiring the highest levels of commitment and trust. While original leads Lorinet Foundation and UNICEF Mongolia will continue to champion, the formation of the Steering Committee is expected to create a favourable environment for more shared responsibility model and greater co-ownership among its members.
